 - Members shall not knowingly enter into any contract of terms of which are designed to imperil either the rights of labor or the suppliers of materials to receive a fair return for services or goods furnished;
 - Members shall comply both in spirit and letter with rules and regulations prescribed by law and government agencies for the health, safety and progress of the community;
 - Members shall be alert to examining proposed or enacted State and Local legislation detrimental to social, economic and political progress; and;
 - Members shall not perform, or cause to be performed, any act which would tend to reflect on, or bring disrepute to, the Association or any part of the building industry. Members shall not act in a way contrary to the interest of the Association.
